The new complex features a 12,900-SF state-of-the-art LEED Certified community center with a library and computer labs, a new zero-entry pool with saltwater purification, splash pad, playgrounds, sports courts, recreation fitness equipment, passive seating areas, and synthetic recreation fields. The site features native and Florida-friendly landscaping, art installation, LED lighting, a covered bus shelter, wayfinding signage, and parking.
